

WAIVER

For and in consideration of participation in Yellow Batz, LLC, including all related leagues, events, and activities (hereinafter the "Yellow Batz"), I, the undersigned, for myself, my heirs, executors, successors, and administrators (hereinafter "Participant"), hereby agree that Participant will not make a claim against, sue, attach the property of, or prosecute Yellow Batz, LLC including, but not limited to its agents, subcontractors, employees, directors, officers, and affiliates (hereinafter the "Releases").

Participant understands that sports involve physical contact between players, that serious accidents occasionally occur during such sporting activities, and that participants in such sporting activities occasionally sustain serious personal injuries and/or property damage. As a consequence thereof, knowing the risks of participation, Participant hereby agrees to assume all such risks, both known and unknown, even if arising from the negligence of the Releases and to assume full responsibility for Participant's participation in Yellow Batz leagues, events, and activities.

Participant hereby fully releases and discharges the Releases from any and all present or future claims and demands of whatever nature or in any way growing out of personal injuries, property damage, or other loss resulting from participation in the Yellow Batz leagues, events, and activities. Participant acknowledges that the Releases are not responsible for the condition of any playing field and/or equipment and releases and waives all claims against the Releases for any injury, damage, or loss that may arise therefrom.

Participant's signature below certifies that Participant understands, consents, and agrees to release, indemnify, and hold harmless the Releases from any and all liabilities incident to Participant's participation in the Yellow Batz leagues, events, and activities, even if arising from the negligence of the Yellow Batz, LLC or other participants in the Yellow Batz, LLC. Participant agrees that it is Participant's personal responsibility to adhere to all rules and regulations and accept them as a participant in the Yellow Batz leagues, events, and activities. Participant's signature further certifies that to the best of Participant's knowledge and belief, Participant has no physical restrictions that would prohibit participation in the Yellow Batz leagues, events, and activities.

I agree and consent to grant Yellow Batz, LLC the absolute and irrevocable right and permission to use my name and likeness to reproduce, edit, exhibit, project, display, copyright, broadcast and publish - images, moving pictures and/or videotaped images of me with or without my voice, or in which I may be included in whole or in part, photographed, taped, videotaped and/or recorded and to circulate the same in all forms of Yellow Batz, LLC projects, marketing and/or any other lawful purpose whatsoever.
